# Portfolio Fund Holdings

The Primark Meketa Private Equity Investments Fund is a closed-end interval fund designed as a core private equity holding that seeks to generate long-term capital appreciation through a diversified portfolio of global private market investment opportunities. The Fund accesses private equity investments through primary and secondary private equity funds, direct co-investments in private companies and registered public companies that invest in private businesses.
